## **OLD BUSINESS:**

- 1. President Johnson expressed a heartfelt thank you to everyone on behalf of Puppy Creek VFD for all those that came out for Captain Chad Autry's Memorial Service. Sadly, Capt. Autry was killed in a tragic accident on April 7. He faithfully served at Stoney Point and Cumberland Road here in Cumberland County.
- 2. President Johnson discussed the foam replacement process. Chief Chris Davis from OSFM advised that we are 30-60 days out for pick-up of our current PFAS foam. The disposal process is still being worked through a contractor in Charolotte for the removal of old foam. The state will dispose of our foam but does not have the funding to replace it. Procurement will have to be secured with the SCIF fund. The newest Green PFAS Free Foam has been identified. Private vendor wants \$30 per 5-gallon bucket plus \$30 per bucket for disposal of old foam. It will be picked up from one location to save on travel costs between locations.
- 3. President Johnson along with Director Gene Booth discussed the Digital Dispatch process. Please submit the needed blueprints with dimensions of each space and not an overall building dimension. Internal Office space also will be required to finalize the programing.
- 4. President Johnson wanted to remind everyone that all NFIRS must be submitted NLT March 31, 2025, to OSFM on the NFIRS portal. You can set up 1<sup>st</sup> Due to automatically do this by quarter as long as all your calls have been authorized. This is also a contract requirement for VFDs.
- 5. President Johnson advised that the Association has received a handful of checks through our fund raiser with the National Fire Safety Council. 12 total checks over the past week. The Checks will be forwarded to the National Fire Safety Council.
- 6. President Johnson reminded the chiefs that the 2025 Legislative Day is coming up on Wednesday, April 30<sup>th.</sup> For those wishing to attend, plan on meeting at the NCSFS Building at 0800 which is within walking distance of the General Assembly. Generally, both breakfast and

- Lunch is provided. Legislative Day is especially important to our Fire Service. If you have not been, please consider going and place this important event on your calendar. See Handout in your packets for more details.
- 7. President Johnson advised that the FY 2025/26 CC Fire Service District Grant submission period closed at 5 PM last Friday with every department and one Regional CCFCA Grant submitted. This years grant funding limit was set at \$70,000.00 and he reminded the members that this amount will increase once our portable radio grant has been paid off. We have made 3 of 5 payments of \$518.999.00. The grants will be reviewed during the next several weeks with results submitted to the county for inclusion in the FY 2025-26 budget.

## **NEW BUSINESS:**

- 1. President Johnson followed up concerning our upcoming VFIS Workers Compensation Bill. According to the Chairman of the Fire and Rescue Commission Workers Compensation Board Mr. Cloyce Anders the General Assembly will fund our Workers Compensation liabilities for the up-coming FY 2025-26 state budget for the last time. We have benefited over the past four (4) years where the North Carolina General Assembly has paid annual workers compensation fees for VFDs across North Carolina since COVID. Starting next year, we must be prepared to assume once again paying our Workers Compensation liabilities from our annual budgets. Please plan ahead and budget for this purpose. He asked all members to please take a minute to thank our delegation when you see them for their support and paying our annual workers compensation fees since 2021
- 2. President Johnson reminded all that it's time for the <u>2025 Valor Awards Submission</u> which is open through the beginning of July. Chiefs are encouraged to please use the QR code on the flyer in your packets. Every department should have at least 1 Merit Award recipient and should also submit your FF or Fire Officer for the year. It only takes about 5 minutes to complete the on-line submission form. Only 1 narrative is necessary briefly justifying your submission. Narratives for Life Safety or Valor will take just a little more time and justification for the awards selection committee to fully understand your request.
- 3. In addition to the Valor Awards Flyer, President Johnson also drew attention to additional fliers that are in your packets.
  - a. FSU is hosting an Autism Awareness Workshop on Wednesday 7 May from 9 until 12
  - b. FFD is hosting a READY Camp on June 9<sup>th</sup> through the 13<sup>th</sup>. See the flyer for more details.
- 4. President Johnson advised the chiefs that Director Gene Booth will be retiring soon from the CC EOC. His retirement date is effective April 30<sup>th</sup>, 2025. Special thanks to Gene for his countless years of service in the county. May 7 retirement ceremony begins at 3pm at the EOC, and we will recognize Gene with our association retiring plaque.

- 5. President Johnson discussed that a few changes are on the horizon following the recent Fire and Rescue Commission meeting. The Certification Board for FF I & II Standard Re-write is coming up. A committee has been assigned to complete the re-write. Chief Johnson mentioned a topic at the FRC meeting earlier this month about the issues with the current block system and the effects it is having on our Volunteers. He further requested to receive committee meeting dates and locations. There is good support from the FRC members to make changes with priorities and there will also be a slight increase in hours if we go back and allow single core classes according to Cert Board members. According to Fire Chief Derrick Clouston who is the CERT Board Vice-Chair, Chief Murphy is on the re-write committee.
- 6. Westarea Fire Department Chief Scott Bass highlighted the dedication and service of Association President Freddy Johnson Sr. Chief Johnson has faithfully served as our President for a total of 25 years counting his two one-year terms in 1987 and 1988. Chief Johnson has always prioritized the collective efforts and welfare of all departments over personal or Stoney Point interest. Despite the demanding nature of the position, Chief Johnson has never received compensation or formal recognition from the association membership. Recognizing his valuable contributions to our association Chief Bass proposed a *MOTION* to provide President Johnson with a \$1000.00 monthly stipend as a token of appreciation for his unwavering commitment. The *MOTION* was *SECONDED* by Pearce's Mill Fire Chief Tracy Smith, and *unanimously APPROVED* by all members present through a roll call vote. President Johnson was surprised and expressed his gratitude to the membership for their support and pledged to continue serving the association with dedication.

## Memorandum on the Use of One-Way Pager Devices on VIPER

The VIPER System Administration has observed that some agencies are utilizing one-way voice pagers for two-tone paging in dispatch operations. It is crucial to understand the limitations of such devices within the VIPER system.

System Configuration and Limitations:

The VIPER system is designed to route radio calls within a talkgroup only to sites where a subscriber radio with a valid VIPER ID is affiliated. This configuration differs significantly from a system that broadcasts to all available sites.

**Agency Responsibility and Liability:** 

Agencies choosing to rely on one-way voice pagers for two-tone paging/dispatch do so at their sole risk. The VIPER System Administration and the North Carolina Highway Patrol assume no liability for potential failures or issues arising from the use of these devices.

## Technical Considerations:

One-way pager devices, unlike standard two-way subscriber radios, are often unable to adapt to system-level changes. Consequently, these pagers may experience operational disruptions or failures during system updates or modifications that do not affect two-way radios.

Disclaimer of Guarantee:

The VIPER system does not guarantee successful page delivery to any device other than a two-way subscriber radio.

Recommendation:

While this memo is not forbidding the use of one-way pagers, it is strongly advising against it. The use of two-way radios is the optimal and recommended method for dispatching.






