OLD BUSINESS:

- 1. President Johnson discussed the foam replacement process for the three county foam trailers. OSFM has been designated to spearhead the replacement project with state funds going to OSFM. Chief Chris Davis with OSFM recently verified foam on hand for accurate replacement. The state will disperse our foam but does not have the funding to replace it. Procurement will have to be secured with the SCIF fund. The team is still waiting for information on the newest Green Foam
- 2. President Johnson announced that our Surrey Fire Safety House new wrap and graphics have
 - been completed and the house was picked up from Specialty Graphics in Angier. There was a delay with the NFPA logo, but the issue has been mitigated. We have an appointment at HGR's Trailers on Thursday April 4, 2024, for the installation of a new battery operated / electric awning. Once completed we will complete a total maintenance check of all systems, and we will also reach out to Surrey Safety Houses to inquire about updating all the old and outdated electronics in the house to current technology. The safety house will remain out of service until all updates and services are complete.




- 3. President Johnson discussed our current AED dilemma surrounding the excessive cost of replacement pads and batteries. He is recommending that we use the funds currently available through the Health Department for CCFCA AED pads and battery purchases. The recommendation is that we replace 130 of our current AEDs and purchase 130 Stryker LIFEPAK 1000 which are compatible with EMS thus allowing PAD exchange with the responding medical unit. To affect this purchase and exchange Cumberland County is requesting that we turn in our current CARDIAC Science Power heart G5 AEDs for distribution in county owned facilities including schools. To utilize the ARP funds the issue goes back to the ARP Committee where Fire Commissioner Keefe is chair. With 100% voting membership in attendance the Chiefs concurred with exchanging our current Power heart G-5 AEDs and pursuing the purchase of 130 Stryker LIFEPAK 1000 which are compatible for direct AED Pad Exchange on the scene with the responding Cape Fear Valley Medic Unit. A presentation to the ARP committee is scheduled for Monday May 6, 2024, starting immediately after the regular scheduled Commissioners Meeting. President Johnson will follow-up with Commissioner Keefe.
- 4. President Johnson informed the membership that he is working with Cumberland County Emergency Services Director Gene Booth to address needed tweaks to the 2019 County Fire

Contract, which Expires on June 30th, 2024. Once this is finalized, we will provide a copy to each district Chief. He provided an example of a required update dealing with our required annual audits, which has already been amended but needs to be included within the new 2024 audit.

- 5. The Cumberland County Service District Grant was open on Monday April 1st and will remain open until 5 pm Friday April 26, 2024, this week. A grant review committee will convene thereafter to review grants. \$60,000 is the limit. Grants submitted that are more than \$60,000 will be returned. Please follow the following established Cumberland County Fire Services District Grant administrative rules.
- 6. First Due RMS Implementation Update is moving forward, with all stations POC receiving emails. President Johnson asked all chiefs to ensure that a station POC is assigned and participates with all implementation venues. This will be done via zoom and all vital sessions recorded and placed in the implementation library for everyone to review. He also advised that the association has a pending bill from Central Square for \$2,340.00 that includes Public Safety Project Management Services, and Public Safety Technical Services. Central Square is what links our departments and First Due RMS to CAD. The bill is due when all services have been completed.
- 7. Chiefs Logan Herndon and Ronnie Marley represented CCFCA at FDIC 2024 (April 16 20, 2024) in Indianapolis, Indiana with over thirty (3) Cumberland County, fire service members attending. 30 Cumberland County members were present for the Cumberland County Fire
 - Service Photo. Special thanks to Chief Bradshaw and the Vander VFD for the impressive FDIC display of Vander's new Rescue Truck CRES-2.





- 8. Special thanks to all those Chief officers that came out and completed their make-up picture. Seventy percent of those who requested supported the request.
- 9. President Johnson reminded the Chiefs that the FY 24-25 county fire department budget forms ae due back this week on April 24, 2024, to county finance. This is a contract requirement.

NEW BUSINESS:

1. A special presentation was made by the Stedman Mayor Martin Jones, Fire Chief Justin Nobles and President Johnson Sr. to Cumberland County Emergency Management Planner Laura Smith. She has tirelessly served Cumberland County in the EM planner position for 8 years. Laura accepted the Emergency Management Coordinator's position with Fayetteville Fire Department.







- 2. 2024 <u>Legislative Day</u>. A handout has been provided in your packet. On Wednesday, May 15th starting at 0800 hours, those interested, including President Johnson will meet in the quorum Center. The quorum center is on the first-floor conference center of the NCSFA Building, 323 W. Jones Street in Raleigh. Parking is normally an issue to arrive early to allow time to find a parking spot. Be present so together we can stand united, and our voices heard.
- 3. Ed Newsone from National Safety Council made a short presentation on a funding venture for area communities to help offset the cost of Public Education items for schools and Public Relation Events. In 2023, the organization raised over \$263,000 for first responder organizations. Several regional departments already use their services, but more are encouraged to investigate the valuable service provided.
- 4. The annual Archie Cox Golf Classic is coming up in the fall. The date is 27th of September hosted at Cypress Lakes Golf Course. Put a team together and support this worthwhile event. A flier is included in your packet for registration details.
- 5. LEPC will be meeting later this week on the 25th of April. Meeting will begin at 10 am at the Cargil Fay Facility located at 1754 River Road. Our point of contact for the meeting is Chief Herndon. If you have any questions, please reach out to him on the matter.

- 6. In honor of National Telecommunicators Week, CCFCA has provided food trays and a heartfelt thank you note to all our Cumberland County/Fayetteville Dispatchers. They consistently do an amazing job, and we owe them our gratitude.
- 7. IAW with our By-Laws, at our next monthly meeting in May we will hold Bi-Annual Elections of the Executive Committee. If you are interested in serving on the Nomination Committee, please contact President, otherwise we will receive nominations from the floor during the May meeting. Election outcomes are effective July 1st, 2024.
- 8. 2024 Valor Award are tentatively scheduled for Tuesday September 10, 2024, starting at 0730 at Manna Church on Cliffdale Road. An initial meeting will be later this week to iron some key details regarding nomination submission details. He urged all Chiefs to think about nominating a deserving member. Nomination forms will be sent out via email, with paper copies distributed during our May meeting. Go ahead and review your membership, whereas every fire department should have at least one (1) Merit Award presentation. The remaining categories are Life Safety and Valor.

CCFCA Records Management System (RMS) Committee Meeting Minutes March 13, 2024

The CCFCA RMS Committee Meeting was called to order by Committee Chair B. Hanzal at 10:00 AM. The meeting was conducted at the Cumberland County Emergency Operation Center (EOC) at 500 Executive Place, Fayetteville.

<u>Members Present:</u> Asst. Chief Brandon Hanzal, Fire Chief Steve Parrish, Captain David Dunn, Asst. Chief Jeremiah Williams, Lieut. Robert Hurlburt (Conference call),

Members Absent: Asst. Chief Jonathan Faircloth (unable to attend but did cast a vote)

Others Attending: Assistant Chief Jason Hulon requested to attend the first due DEMO and final meeting and was allowed to vote.

Committee discussed the Pros and Cons of three different record management systems, ESO, Image Trend, and First Due. The Committee used the following criteria to evaluate the different systems.

 VENDOR EVALUATION: The committee should thoroughly research and evaluate multiple vendors, (ESO, Image Trent, First Due, & others) providing RMS solutions. Consideration should include their track record, experience, customer reviews reputation, service support, implementation timelines, and scalability and most importantly the capturing of current historical ER records into the newly recommended RMS.

First Due was the only vendor that decided to do an <u>in-person</u> demo. ESO and Image Trend did a virtual demonstration. All Three systems provide support in the same fashion using a support webpage. First Due was the only vendor that assigned an (agent) to each account to assist with issues that cannot be resolved on the support page. We met with the following vendors.

- ESO (Web demo Feb 6, 2024)
- Image Trend (Web demo Feb 20, 2024)
- First Due (In-Person demo Feb 27, 2024)

2. SYSTEM REQUIREMENTS: The new RMS should integrate the required functionalities and features that improve emergency reporting efficiency. Areas to focus on may include Cloud based, incident tracking (NFIRS), Incident Management, training, ISO, inventory management, inter-agency data sharing, management reporting and analysis tool capabilities, user interface and ease of use to mention a few. The committee should also take a close look at the possibility of incorporating or merging currently used notifications systems into new RMS systems if available. With our goal of implementing Digital Dispatch the new RMS must be compatible with our Computer Automated Dispatch (CAD) systems and interfaces.

All three systems are very similar in this category. web/based cloud storage. All vendors offer the modules that will meet the counties needs for tracking data. Image Trend and First Due did stand out in their ability to report on data that is input. First Due was the only company that had an actual application for dispatch alerting, messaging, and paging.

3. USER FRIENDLINESS: The committee should prioritize the ease of use and intuitive interface of the new RMS. It should be accessible to users with varying levels of technical expertise and should minimize training and onboarding time for all stakeholders.

After looking at the three vendors the committee agreed the most fluid easy to use system was First Due. Some of the committee members were able to use the sandbox accounts and overwhelmingly chose First Due when it came to system layout and ease of use. Image Trend came in a close second for layout and ease of use.

- 4. COST ANALYSIS: The committee should conduct a detailed county wide bundled cost analysis for each potential RMS solution, considering both upfront costs and on going recurring maintenance expenses. This analysis should also include potential cost savings or efficiencies that can be achieved through the implementation of the new RMS system.
 - > ESO was our cheapest option at \$51,828 but lacked interface and support in the operating system.
 - > Image Trend was a few thousand higher at \$54,000,
 - ➤ First due was definitely the most expensive at \$85,000 but the need to pay for IAR would no longer be necessary. When subtracting the \$14,000 IAR the price dropped to \$71,000,00.

COMPATIBILITY & INTEGRATION: The committee should ensure that the new RMS integrates seamlessly with existing systems such currently in use CAD systems, mapping tools, and other relevant software utilized in emergency reporting. Compatibility with mobile (Freedom App or alike programs) will also be essential in working in the field during emergency incidents.

All three system stated data can be imported seamlessly as long as it can be moved into CSV format. (ER is capable of doing that). Photos or PDF data can be moved over but may require some additional work on the end user.

6. SECURITY AND DATA PRIVACY: The committee should assess the security measures, data encryption protocols, and measures to ensure compliance with relevant laws and regulations concerning data privacy and confidentiality (HIPPA).

All three vendors store and backup data in the same manner. The committee could not vote on a particular standout in this category since all three vendors are following proper privacy and confidentiality standards.

After a thorough and exhaustive search that involved reviewing three (3) different Records Management Systems, we are pleased to announce that *FIRST DUE RMS* has been selected *UNANIMOUSLEY* as the system that best meets our needs. The advanced capabilities, features, and user friendliness interface offered by *FIRST DUE RMS* far surpass those of other systems considered. Although higher in price, the committee believes that the additional expense is justified by the comprehensive functionality and benefits that will enhance our operations and improve efficiency county-wide. Noteworthy is the fact that the App that comes with the *FIRST DUE RMS* system would allow the Chiefs Association to no longer have to partner or pay for services from *IAR*. The *FIRST DUE RMS* application is able to notify the volunteers and staff with a much more robust interface. (Capable of Cad connection, member paging and pre plan data).

<u>Image Trend</u> was the committee's second choice. The city of Fayetteville currently uses this system, and its capabilities are similar but just did not score as high in interface and usability. <u>We would also have to continue to use IAR in conjunction with Image trend as there is not a solution for CAD interface for end users</u>.

<u>ESO</u> unanimously just did not stack up in any category in comparison to First due or Image Trend. The system was in our opinion overall not put together well, it was not user friendly or easy to run data driven reports.



Minutes - County Training Officer Meeting April 17, 2024

Attendees: Kevin Murphy (13), Jessica Lasitch (26), Roy Duarte (5), Jeff Canady (21) and Michael Bartch (RFRTC).

Meeting called to order at 1900.

Michael Bartch – Stated that TR/VMR can be run on the weekends if desired by the departments. He wants to run three fire academies; one in the north, one in the west and one east of the river simultaneously. He wants to team up with several fire departments to make this happen. Although six students per class is usually the minimum, he said he would run the classes with less. He further stated that he will run live burns for fire departments at night during the week and on the weekends. "Q" Prep is an initiative to prepare upcoming instructors to pass the Q School successfully. This would include a comprehensive written test and fifteen practical exercises. He said he would run this with 6 people. He is starting an Instructor Apprentice Program where he will take upcoming instructors, align them with a senior instructor, and have them teach classes. He would pay them to assist, but not at an instructor rate. They cannot grade the practical exercises, but can shadow the instructor.

Kevin Murphy – the 580G program was discussed at length. The pros and cons were raised regarding conducting the program in-house or at the RFRTC. Tender Task Force Training was discussed with the upcoming Stedman drill used as an example. The eastern side of the county conducts a large tender drill each quarter, which is a great initiative that allows departments to meet their ISO multi-unit drill requirement. Fire Officer I is a requirement for all officers in North Carolina. As most of us are coming into the ISO inspection window, it would be a good idea to schedule this class for your department before the rush for completion takes place.

Michael Bartch—In the future, certification certificates will be emailed to the student, eliminating the need for printed certificates.

There will be an Autism For 1st Responders class on June 29 at the RFRTC.

The meeting was adjourned in 1936 by Kevin Murphy.



Dear Senator Tom McGinnis,

I am writing to seek your assistance in extending our State Capital Infrastructure Grant (SCIF) fund appropriations for the Cumberland County Fire Chiefs' Association (CCFCA). Our association has been utilizing the grant funds for critical projects aimed at improving firefighting equipment needs and emergency medical programs in our community.

We are specifically requesting an extension of time to align our budget Scope of Work and alleviate the financial burdens incurred by the association. Currently, we are making an annual payment of \$518,988 for the purchase of 444 portable Motorola radios and accessories distributed to all 15 volunteer fire districts in the county. These radios were financed for 5 years, with 3 years remaining on the loan. The annual payments have been constraining our ability to address other critical needs with the community, including maintenance of firefighting equipment and supplies.

The purchase of the radios was necessitated by the Federal Communications Commission (FCC) digital requirements, which go into effect on January 1, 2026. Our previous analog radios were not compatible with the new digital standards, making the upgrade essential for effective communication within the fire departments.

The SCIF grant funds have been instrumental in funding various projects for both firefighting and equipment needs. Grant ID #30211 has supported equipment projects and initiatives such as fire prevention materials, smoke alarms for low-income and targeted areas, maintenance of our Fire Safety House, as well as up-keep and utility costs for the association's storage facility.

While grant ID # 30212 is new and the associated funds will be utilized for the purchase of essential medical supplies, equipment, and the sustainment of AEDs and much needed NARCAN purchases for overdose incidents and heart attacks.

To ensure the sustainability of these critical projects and address the financial strain imposed by the required radio purchase, we are requesting an extension of both grants through the 2026/27 fiscal years, expiring on June 30, 2027. This extension would allow us to pay off the radio grant while continuing to meet the priority needs outlined in our Scope of Work submitted to the Office of State Budget and Management Office (OSBM).

I kindly ask for your support in advocating for the extension of our SCIF funds appropriation to enable us to continue serving the community effectively. Should you require further information or clarification, please do not hesitate to contact me at your convenience.
