1. President Johnson introduced Mr. Don Smith as the third Arson Investigator.
2. Doc Nunnery advised the association that a PL Code was available for fire departments purchasing new radio,s. The code is for fire channel 1 & 2 as follows 3A Fq. 127.3 MHz.
3. Benny Nichols advised that the State is in the process of adopting NFPA Standard 472 for hazardous materials response at all levels. Level 1-2-3. This standard will provide training to departments of North Carolina.
4. President Johnson introduced Mr. Ronnie West as the new Fire Chief for Hope Mills.
5. Inspector Ricky Strickland advised that his office now had received some state fire report forms and because of the small amount received departments would be given only the amount they turn in each month.
6. President Johnson presented a slide presentation of all the fire departments in the county and explained how they have expanded over the years.

At the April meeting it was passed by a majority vote of all members present to have all the candidates running for office of county commissioner to be present at the May meeting to answer questions from the association. These answers will be helpful to the association for determing which candidates they are going to support.
