OLD BUSINESS

1. President Johnson clarified information that went out on e-mail that may have confused several chief's concerning the Firehouse Cad Interface. Chief Lucas was quick to respond but the Firehouse Cad interface has nothing to do with the mobile data terminals. The Firehouse Cad interface simply provides information to each Fire Department when they log into the Firehouse Web to enter reports, whereas the report will have already been initiated with call information gathered by dispatch. Once all the

issues have been cleared up and the system is running as intended the rip and run will no longer be necessary.

- 2. Chief McLamb provided a quick update concerning all our Firehouse issues to include training issues. He stated that Firehouse will provide us with training and the dates and times will be forthcoming. He stated that we are still in the initial phases and have to work through un-foreseen issues as they occur. He stated that county IT has two technicians on call 24 X 7 in case the server goes down. He also stated that each department will maintain their individual composition and other departments will not be able to see their data. Deputy Director Timmy Mitchell stated that there are several (3) in county IT and (3) more over at the Sheriff's Office Training Center and the odds of (6) servers going down at the same time are slim to none.
- 3. Chief McLamb stated that county IT has started the process of moving data over to the new server and hopefully by the end of the month all departments should have been moved over to the new server. They will be providing log in information and will also assist any departments that may need assistance in the process. Lastly he stated that many issues are still being worked and it will be later this year or sometimes next year before all our issues are fully implemented. President Johnson stated that some of the automation process we specifically asked about is not ready although the Firehouse Sales staff told us it was. We are working the issues and will keep you informed.

NEW BUSINESS:

1. President Johnson informed the membership about a bill that is on the fast track going through the legislative process. House bill 989 deals with Permanent Plates. The new bill as currently written would remove Rescue Squads and Local Volunteer Fire Departments from being eligible for permanent plates. Instead we would have to purchase another special plate that has an annual re-newel fee. Please contact our legislature to object this move. He stated that he would contact Senator Meredith and other legislatures both in the house and in the senate in the morning to inquire about this issue.

Both will be assigned to the same tactical channel and this will also cut out a lot of information that is currently being related through dispatch and therefore will provide for direct communications between the responding fire and medical units. Once patient care at the incident scene is complete the medic units will switch back to their EMS channels. Chief Marley raised some concerns about overcrowding the talk groups.
