Education & Training

1. Chief Alan Cain reported that grandfathering into the State Firefighter Certification program would be ending in the very near future and asked that all departments fill out their certification forms and turn them into Jerry Blooms office as soon as possible so that any of the men could be granted certification under the grandfather clause before it is cancelled.
2. Also the quarterly training schedule was handed out to departments that wanted them.
3. Any department wishing to assist with the Eastern Fire Seminar to be conducted in March 1989 is to contact the fire fighters association or the Chairman of the Education & Training committee of the Fire Chief's Association.

Standards & Mutual Aid

1. A request was made to have John McInnis add into the 1989-1990 mobile air system budget a price for 24 new 2216 psi air bottles so that the present bottle rack on the vehicle could be filled to its capacity.
2. Any department going outside the county to assist other departments and call for assistance from Cumberland County is to continue to utilize the Cumberland County Fire Department Standard Operating Procedures on all type incidents.
3. Special thanks was given to Chief Billy Clark of the Manchester Fire Department and to the Cumberland County Emergency Response Team for an outstanding performance at the Harnett County incident.

2. Fire Commissioner Bob Lewis expressed his feelings to the association for the performance of all fire departments in this county for their outstanding service, s they are performing to the citizens of Cumberland County.
3. Chief Jackie Lee reported that the base radio at the Wade Fire Department was out of service and as soon as the department could raise the money it would be repaired or replaced.
4. Chief David Cashwell announced the Stedman Fireman, s Day to be held October 1, with a parade beginning at 10:00 a.m.
5. President Freddy Johnson advised the association of a telephone call he had received from Sheriff Morris Bedsole asking for support from the fire departments to help sale tickets to raise money for a organization that he is a member of called Youth For Christ. Each department was asked to sale fifty tickets. A roll call vote was taken to see what departments were interested in helping sale these tickets. Sheriff Morris Bedsole will deliver the tickets to each department that requested them as soon as possible.
6. President Johnson advised the association of a problem that had occurred with the fund raiser being conducted by the chief, s association. This problem will be taken care of.
