The meeting was called to order by President J.E. Hall at 20:00 hours. Roll was called: 20 Departments were represented and 9 associate members were present.

Dick Clark - Valen Fire and Safety discussed the benefits of group purchasing protective breathing equipment. Several departments are considering this option; any others may contact him at the earliest convenience.

OLD BUSINESS:

Assistant Fire Chief David Chavis announced that the foam trailers have been delivered to the respective stations. Delivery of back ordered equipment is expected within the next couple of weeks and that the trailers should be fully operational by the next association meeting. He also stated that the S.O.P.'s, preventative maintenance schedules and inventory sheets are in their final stages.

Some concerns regarding the weight transfer of the trailers and the vehicles pulling them were discussed. Committee will look into these concerns and report at the next meeting. It was noted that foam leaks from the front 1 3/4" discharge valves. The manufacture will be contacted regarding this.

TRAINING COORDINATORS MEETING
APRIL 1995

THE APRIL MEETING WAS HELD AT STATION 15 ON THE 17TH AT 7PM.
STATIONS REPRESENTED WERE:

STATION 03- TODD GAUTIER
STATION 04- BOB LANDS
STATION 05- DAVID GRICE
STATION 06- JIMMY IVEY
STATION 11- JOHN HOUSE
STATION 15- CHRIS HARRISON
FTCC - BILL VILE

THE MEETING WAS CALLED TO ORDER ALLOWING MR. HILL FROM THE DEPT. OF INSURANCE TO SPEAK. MR. HILL FIRST TOLD THE GROUP OF SOME NEW CHANGES THAT ARE IN EFFECT. AN INSTRUCTOR CAN GO OVER TEST WITH STUDENTS AFTER THE TEST HAS BEEN GIVEN AND ARE RESEALED IN AN ENVELOPE. AN INSTRUCTOR CAN GO TO FTCC AND LOOK OVER THE TEST BANK QUESTIONS BEFORE THE CLASS IS GIVEN. THIS IS SO AN INSTRUCTOR CAN BE PREPARED FOR CLASS. THERE WAS A LONG DISCUSSION ON THE HOURS BY THE STATE REGARDING FIREFIGHTER CLASSES. ENCLOSED IN THIS LETTER YOU WILL FIND A FORM WITH HOURS ON IT. MIKE HILL STATED THAT THOSE HOURS WERE NOT RECOMMENDED BY THE STATE. THEY ARE ONLY MAXIMUM HOURS. AN INSTRUCTORS CAN LOWER THE HOURS IF THEY FEEL THEY CAN DELIVER THE PROGRAM IN A SHORTER TIME PERIOD. THE INSTRUCTOR NEEDS TO LET FTCC NO WHAT TO MAKE THE CONTRACT OUT FOR. THE STATE WILL TAKE ACTION ON THE AMOUNT OF HOURS IN THE NEXT FEW MONTHS. CHRIS ASKED IF THE SCHOOL COULD NOTIFY THE DEPARTMENT IF A STUDENT FAILS A CLASS. BILL VILE SAID HE COULD NOTIFY THE CHIEF OF THE DEPARTMENT BUT IT WOULD BE EASIER IF THE TRAINING COORDINATORS WOULD LOOK AT THE CERTIFICATIONS ISSUED AT THE END OF THE MONTH. THERE WAS SOME DISCUSSION ABOUT THE TEST THAT ARE NOW GIVEN. THE WORDING IS BAD IN SOME TEST. MIKE HILL SAID TO WRITE DOWN ANY PROBLEMS WITH TEST AND SEND TO HIM. HE WILL TAKE CARE OF THEM. BILL VILE ASKED WHAT THE CROSSOVER CLASSES FROM THE FIREFIGHTER PROGRAM TO THE BRT AND ART PROGRAM. MIKE HILL WILL SEND HIM A COPY OF THEM. JOHN HOUSE ASKED HOW CUMBERLAND COUNTY FIT IN WITH THE REST OF THE STATE IN TRAINING. MIKE HILL STATED THAT HE WAS NOT SURE EXACTLY WERE WE WHERE IN NUMBERS. HE ALSO STATED THAT THE REASON TRAINING IS DOWN MAY BE BECAUSE SO MANY FIREFIGHTERS ARE ALREADY CERTIFIED. THEY ARE TRYING TO BRING IN NEW CLASSES SUCH AS THE FIRE OFFICER PROGRAM. THE TELECOMMUNICATORS AND PUBLIC FIRE EDUCATORS PROGRAM JUST TO MENTION A FEW. MIKE HILL GAVE US A NAME OF A LADY AT THE STATE THAT WE COULD CONTACT IN REGARDS TO THE PUBLIC FIRE EDUCATORS PROGRAM. THERE ARE THREE LEVELS TO THE PROGRAM AND EACH ARE 36 HOURS LONG. STATION 3 WILL CONTACT HER. FROM NOW ON AT THE STATE, IF YOU COMPLETE THE PROGRAM AT THE END OF A QUARTER YOU WILL RECEIVE YOUR CERTIFICATION QUICKER. IF YOU FINISH AT THE BEGINNING OR MIDDLE OF A QUARTER YOU WILL HAVE TO WAIT.

THE CERTIFICATIONS ARE BEING DONE ONCE A QUARTER NOW WHEN THE DUMP FROM THE COMMUNITY COLLEGE IS DONE. JOHN HOUSE ASKED IF AN INSTRUCTOR COULD TEACH A CLASS AT HIS DEPARTMENT WITHOUT GOING THROUGH A COMMUNITY COLLEGE AND STILL BE ABLE TO SIGN OFF ON OBJECTIVES. MIKE HILL SAID NO, WE MUST GO THROUGH A DELIVERY AGENCY. JOHN HOUSE ASKED WHAT IT WOULD TAKE TO BE A DELIVERY AGENCY. MIKE HILL SAID THAT WE WOULD HAVE TO SEND A LETTER REQUESTING IT. A COMMITTEE WOULD THEN LOOK INTO IT. MIKE HILL STATED THAT IT WAS HARD TO BECOME A DELIVERY AGENCY BECAUSE THE STATE WAS NOT ALLOWING IT TOO OFTEN. THERE ARE 58 COLLEGES THAT ARE RECOGNIZED AS DELIVERY AGENCIES AND 16 FIRE DEPARTMENTS THAT ARE RECOGNIZED AS DELIVERY AGENCIES IN THIS STATE. MORE STATIONS ARE DENIED THAN ARE APPROVED. MIKE HILL STATED THAT FTCC EARNS MONEY FROM THE STATE FOR RUNNING CLASSES. IF THE DEPT. DID NOT RUN CLASSES THRU FTCC THAN FTCC WOULD LOSE MONEY. THIS WOULD HURT THE COUNTY BECAUSE THERE WOULD BE NO MONEY FOR FIRE TRAINING AND NEW EQUIPMENT TO TRAIN WITH BY FTCC. MIKE ALSO STATED THAT ONCE YOU BECOME A DELIVERY AGENCY YOU CAN'T ALLOW FTCC OR ANY OTHER COLLEGE TO COME INTO YOUR DEPARTMENT TO TEACH CERTIFICATION CLASSES FOR THE LEVEL II PROGRAM. MIKE WENT ON TO SAY THAT CERTIFICATION TRAINING WAS AN EXPENSIVE PROCESS AND THAT FTCC RECEIVES STATE TAX DOLLARS FOR TRAINING AND HAS A COMMITMENT TO TRAINING FOR FIRE AND RESCUE BUT IF YOU WANTED TO APPLY TO THE COMMISSION TO BE A DIRECT DELIVERY AGENCY YOU COULD. (ENCLOSED YOU WILL FIND WHAT THE STATE REQUIRES OF YOUR DEPARTMENT TO BECOME A DELIVERY AGENCY. YOU MUST HAVE OR HAVE ACCESS TO THE FOLLOWING EQUIPMENT.) MIKE HILL ASKED WHAT WE THOUGHT OF THE NEW LESSON PLANS. THE GROUP FELT THEY WERE ADEQUATE FOR OUR NEEDS. MIKE HILL REMINDED EVERYONE THAT IT WAS ONLY A PLAN AND NOT TO USE IT AS YOUR TEACHING GUIDE ONLY AS REFERRAL. MIKE HILL HAD NOTHING ELSE TO SAY AND THERE WERE NO MORE QUESTIONS FOR HIM. WE THANKED HIM FOR COMING AND INVITED HIM BACK ANY TIME. BETWEEN MIKE HILL AND KEN BRISCOE THERE SHOULD BE A STATE REPRESENTATIVE AT OUR MEETING EACH MONTH. JOHN ASKED BILL VILE IF HE HAD ANYTHING. MR. VILE STATED THAT FTCC IS LOOKING FOR MORE CLASSES TO RUN BECAUSE 80 TO 85% OF THE FIREFIGHTERS IN CUMBERLAND COUNTY ARE CERTIFIED. IF YOU HAVE ANY IDEAS CONTACT BILL VILE. WE ASKED IF THERE WAS ANY PROGRESS ON THE FIRE SCIENCE DEGREE PROGRAM AND BILL TOLD US NO. JOHN ASKED BILL WHY THE FIREFIGHTER CERTIFICATION PROGRAM WAS NOT A CURRICULUM PROGRAM AND THE BASIC LAW ENFORCEMENT WAS. BILL STATED THAT SOME OF THE CLASSES FROM THE FIREFIGHTER PROGRAM CAN BE CARRIED OVER TO A FIRE SCIENCE DEGREE BUT NOT MANY. BILL COULD NOT ANSWER WHY THE FIREFIGHTER CERTIFICATION WAS NOT CURRICULUM OTHER THAN BECAUSE WE DO NOT HAVE A FIRE SCIENCE DEGREE PROGRAM IN THIS COUNTY. WILSON AND WAKE COUNTIES HAVE FIRE SCIENCE DEGREE PROGRAM SO BILL SAID HE WOULD VISIT TO SEE WHAT COURSES ARE REQUIRED IN THEIR PROGRAM.

EVERY DEPARTMENT IN THIS COUNTY NEEDS TO PUSH FOR A 2 YEAR DEGREE PROGRAM IN THIS COUNTY. WITHIN THE NEXT FEW YEARS YOU WILL NEED A 2 OR 4 YEAR DEGREE TO EVEN BE CONSIDERED TO BE AN OFFICER ANYWHERE. THINK ABOUT IT. IF ITS NOT FOR YOU , PUSH IT FOR THE FUTURE FIREFIGHTERS.

STATION 03- (SEE THE ENCLOSED LETTER) PEARCES MILL WILL BE RUNNING THE EMS CON ED PROGRAM BEGINNING MAY 3, 1995. TODD ASKED BILL WHAT KIND OF EQUIPMENT DOSE FTCC HAVE. BILL SAID THAT THE GOAL OF FTCC WAS TO EVENTUALLY HAVE EVERYTHING WE WOULD NEED TO RUN ALL CLASS.

STATION 04- NOTHING

STATION 05- EMT CLASS STARTS MAY 08. DONNA STRONG AND HER HUSBAND WILL TEACH THE PROGRAM. MAY 1-4 WILL BE A DRIVER OPERATOR INSTRUCTOR CERTIFICATION FOR NEW EMERGENCY VEHICLE OPERATORS.


STATION 06- NOTHING

STATION 11- INSTRUCTOR METHODOLOGY BEGINS MAY 16 AT 7PM. THE CLASS IS LIMITED TO 20 PEOPLE WITH 4 ALTERNATES. IF INTERESTED CONTACT LAKE RIM FIRE DEPARTMENT AND ASK FOR THE SUPERVISOR ON DUTY. THEY WILL PUT YOUR NAME ON A LIST. THERE ARE 9 NAMES ON THE LIST NOW.

STATION 15- HAZ-COM CLASS APRIL 27. IN MAY, JUNE AND JULY RICK SWANN WILL TEACH THE 84 HOUR DRIVER OPERATOR PROGRAM.

JOHN HOUSE STATED THAT THE FIRE ACADEMY WILL BE OVER ON THE 25TH AND THE STUDENTS WILL GRADUATE ON MAY 1ST. THE NEXT ACADEMY WILL BE IN AUGUST. YOU NEED TO GIVE THE NAMES OF FIREFIGHTERS INTERESTED IN ATTENDING TO BILL VILE SOON. THE ACADEMY WILL ONLY HOLD 20 PEOPLE. ALL DEPARTMENTS NEED TO LOOK AT THE TRAINING IN THIS COUNTY AND MAKE A LIST OF IMPROVEMENTS THEY WOULD LIKE TO SEE ALSO LIST ANY TRAINING EQUIPMENT , TRAINING AIDS OR ANY TRAINING IDEAS YOU THINK WOULD BENEFIT THIS COUNTY. WE NEED TO START LOOKING AT THE FUTURE OF THIS COUNTY IN A TRAINING VIEW. HOW CAN WE KEEP THE VOLUNTEERS COMING AND ONCE WE HAVE THEM HOW CAN WE KEEP THEM. I KNOW THE TRAINING IS HERE AND ITS ALL AROUND US. WE NEED TO FIND IT AND WE BRING IT TO OUR COUNTY. THIS COUNTY USED TO BE THE BEST PLACE TO TRAIN AND I FEEL THAT WITH A LITTLE WORK AND A LITTLE RESEARCH WE CAN BE THAT WAY AGAIN. 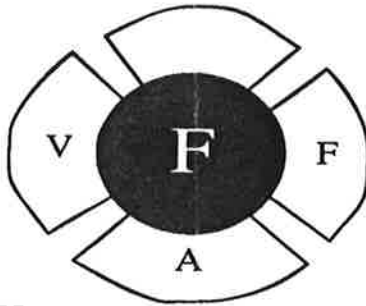
