**Roll Call:** Roll call was conducted with 16 departments and 3 associate members present.

will be approved with the October minutes during the November meeting.

**Treasurer's Report:** The association treasurer provided a current fund balance as \$506,782.44

### **Meeting Point of Interests:**

<u>Next Chief's Meeting</u> will be Monday November 28, 2016. The meeting will be hosted by Stoney Point Fire Department Station 19, located at 2190 Lake Upchurch Drive.

- President Johnson also informed the membership that the December meeting will be one (1) week early due to Christmas and is scheduled for Monday December 19, 2016 at the Sheriff's Office Detention Center.
- Grays Creek VFD Station 24 has the air truck responsibilities during the month of November 2016 followed by Vander.

### **OLD BUSINESS**

- 1. Emergency Services Director Beeman informed the membership that the OSSI Freedom Application proposal is scheduled to go in front of the county commissioners for final approval during the first meeting in November. He stated that due to Hurricane Matthew a meeting in October was cancelled.
- 2. President Johnson advised that Director Beeman today forwarded the Bed Bug Power Point presentation from our August meeting. It's a large file and he will forward it to all members for reference. He thanked Director Beeman for following through with the Bed Bug presentation.
- 3. President Johnson stated that improvements have been made to IAR, but it is still not 100% and many of our calls are still not coming through.

### **NEW BUSINESS:**

1. President Johnson introduced members of the Fayetteville Fire Department Honor Guard, and advised that he recently met with members of the honor guard to discuss honor guard support especially for memorial services for Cumberland County Fire Service members. During the course of the discussion Captain Joyner (Current Honor Guard Commander) and retired Battalion Chief Oloane and others informed him of current guard hardships. Because an Honor Guard program is a very serious matter in nature, appearance and commitment, especially when asked to participate and perform, it is necessary for the Honor Guard to fulfill its commitment, and in order to meet those future challenges a proposal to expand and re-organize the honor guard into the Cumberland County Emergency Services Honor Guard (CCESHG) was proposed. In order for the CCESHG to be fully capable to provide adequate support a three (3) team concept was presented, utilizing at least one (1) member from each Cumberland County Emergency Services Agency. To achieve this goal and to have a fully integrated honor guard representing all CCFCA departments, each Fire/EMS Chief is asked to inquire with his membership to see if they are **ABLE** to commit at a minimum one (1) member to **volunteer** and join the honor guard and make a three (3) year commitment. The CCFCA considers membership with the CCESHG a privilege and encourages active participation by all association members. We also understand if there is a department that is not able to fulfill this requirement due to low membership, or other hardships, and non-participation by no means will restrict required services in any fashion if needed. Because the upfront cost of outfitting a new member with honor guard uniform and equipment is just shy of \$ 700.00 each, along with the training and indoctrination is the reason for the three (3) year commitment in order to retain continuity. President Johnson advised that our county needs an active honor guard that will serve all departments equally when needed. All of us collectively will benefit from honor guard services when the need arises. This will be a tremendous asset for all of us if we do this right, and the members of our Honor Guard will be Ambassadors not only for our association but also for our individual departments. Because the team was planning an internal fund drive in order to provide uniforms, President Johnson stated that the Chief's Association should fund the Honor Guard with essential equipment as long as funds are available. The honor guard will be made part of our memorial committee and will work directly with the memorial committee chairman or Vice President of the Association who has the memorial services responsibility and is

the Memorial Committee Chairman. The new honor guard will devise operational guidelines that will be presented to our association for final approval. A copy of the preliminary draft plan outline is in your packet. A general discussion on the proposal followed amongst all members, with all members in favor of the formation of the Cumberland County Emergency Services Honor Guard. President Johnson also stated that he communicated with the chiefs not present and Chief Hodges, Marsh and Deputy Chief Danny Hill all supporting the honor guard formation. With no further discussion, President Johnson called for a motion.

A <u>MOTION</u> was introduced by Assistant Fire Chief Jason Williams to support the reconfiguration of the Honor Guard to the Cumberland County Emergency Services Honor Guard, (CCESHG) whereas each fire district that is <u>ABLE</u> to appoint at least one (1) member that is willing to make a three (3) year commitment to the Honor Guard and that the Cumberland County Fire Chiefs Association (CCFCA) provide reasonable financial support <u>if available</u> to the Cumberland County Emergency Services Honor Guard with uniform and equipment expenses and that the CCESHG in turn will support all Cumberland County Fire & EMS Agencies with appropriate Honor Guard and related services when needed. The CCESHG Commander, deputy commander or honor guard representative will provide reports, or updates to the CCFCA and attend or be represented at all Memorial Committee meetings and directly work with the Chairman (CCFCA VP) of the Memorial Committee.

The <u>MOTION</u> was <u>SECONDED</u> by Fire Chief Scott Bass and after a general discussion - unanimously <u>APPROVED</u> by all members present this 24<sup>th</sup> Day of October 2016. (See Enclosure # 2 Official Roll Call Vote Form)

President Johnson thanked the membership for their support of this much needed asset, and asked all members to send him the name of their candidate if they have one, whereas he will coordinate with the current honor guard leadership and set up a meeting in order to discuss details, commitment and honor guard protocol to insure the program will be successful. He also asked the chiefs that we as chiefs needed to do our part and let our members participate in training and when suddenly needed for an un-planned memorial service due to a member death. He further asked the members that unless there are any objections with the current uniform, which is sharp, we will stay with the current uniform. A new honor guard patch is being designed for wear on one sleeve, and the patch of the members department will be on the other sleeve. He further thanked the member's of the honor guard for their dedication and strive for our most recent and successful memorial service this month.

In order to move forward he asked all Chiefs to talk with their membership and solicit at least one (1) member if they are able and submit their member's name directly to him, via e-mail or phone call. He also requested, that even if you don't have anyone that can join right now to also let him know as well. He asked that new members still in training are not selected right now, whereas their training would interfere with Honor Guard training. He asked that all names are submitted by or no later than our November meeting, in order to facilitate a CCESHG kick off meeting before the 1<sup>st</sup> of the year.

2. President Johnson stated that while we are on the Honor Guard, Battalion Chief Richtmeyer provided information that our FTCC memorial site plaque is in need of

restoration. The site and plaque is 16 years old now and the weather has taken its toll on our plaque. President Johnson advised the members that an invoice from Breece Monuments places the repairs just shy of \$5,000.00 with the FTCC masonry students repairing the bricks that will be removed in order to remove and remount our plaque. This is something that needs to be done and a vote is not required and funds are within our annual budget.

3. President Johnson spoke about Hurricane Matthew response. He stated that the storm devastated our county and region. The disaster from Matthew was inland and our coastal counties pretty much escaped the storm. He informed the members that two (2) of our departments that he knew of received storm damage, with Cotton being completely flooded out, and is currently running out of temporary quarters and has received tremendous support from their community, a direct attest to their community service. He informed the membership that due to the current hardship he turned on Cotton's WIFI's in order for them to have internet access, or until Time Warner Cable (TWC) can install hardline cable. During the process DECON Trailer # 1, which is housed at Cotton VFD was also flooded and damaged. VFIS is working the claim on our behalf and a confirmation e-mail from the adjuster is located in your October chief meeting packets. He emphasized to the members that any member with five (5) or more years of North Carolina State Firefighters Association roster time is eligible to receive funds from your relief fund pending NCSFA approval, and a guiding principle is devastation. The NCSFA will not approve relief funds if you cannot readily justify that your member is destitute. If your member is a member of the NC Rescue Squad Association they are also taking applications that would qualify an affected member to receive a \$ 200.00 benefit if property justified and verified.

President Johnson stated that he wanted to take a moment and talk about Hurricane Matthew response. He stated that all of us were challenged with overwhelming situations that we are normally not challenged with or have never been exposed too. The good thing is we are all here to talk about these challenges as long as we do so constructively. I know many of you took critical impediments into account and implemented mitigation factors to handle situations, because there was no help coming. Our entire system was challenged and in the end we all made it through, worked together and overcame. For that we should be thankful. We should however record and prepare a constructive after action report for future reference and implement lessons learned from Matthew. Each of you had stories and issues that need to be addressed and mitigated for future incidents. We also need to address if there are issues that require us to look at our critical incident response plans. I don't know if Emergency Services are planning an AAR meeting, but if not we will schedule a special AAR meeting and prepare a comprehensive report. Until such time please write your points down, this is important.

President Johnson briefly touched on the issue of pre-storm preparedness, whereas there was a meeting where the volunteer fire departments were left out. This was brought to my attention from one of our department chiefs after reading about the event in the newspaper. He thanked the COF of Fayetteville for keeping their contract station fully informed of their action plans, as well as the support received from the COF during the response phase. A letter sent to Director Beeman that addressed our issue, was directly dealt with and corrected. County Manager Amy Cannon personally called President

Johnson and took full responsibility along with an apology. President Johnson considers the matter handled and closed.

- 4. President Johnson urged all members to apply to the Assistance to Firefighters Grant Program (AFG) which is currently open. With all the current storm recovery action he will not be able to formulate a regional grant, due to the lack of time. But that is no reason for individual departments not to apply for an AFG grant opportunity. They cannot turn you down if you don't apply.
- 5. President Johnson stated that ABC 11, once again sponsored Operation Safe a Life, where critical Smoke Alarms are distributed to Emergency Services within their viewing area. The Cumberland County supply was picked up, please check with Emergency Services if you have a need for smoke detectors. Available smoke detectors are the 10 year battery life detectors.

He also stated that there is a plan in the works for a similar program to give out Carbon Monoxide Monitors in the future. As we get more information we will disseminate it down to each of you.

- 6. President Johnson informed the membership that our ID Card Printer is down due to a worn out print head. It will cost about \$800.00 for the part, however the company informed him that our current printer is not being supported anymore and has been replaced. We can fix it because the part is available, but they recommended the purchase of a new and up-to-date printer. A new printer is \$2,500.00. Our current printer has served us well over the last five or six years. Technology and associated programs change so fast and it is catching up with our printer. The membership advised to move forward and replace the printer utilizing repair funds from our budget. No motion was needed for approval.
- 7. President Johnson informed the members that in accordance with our By-Laws Article 2 Section 13 Termination of Membership states that missing three (3) consecutive unexcused absences calls for removal from the membership roll. Two (2) of our associate members District Attorney, and Civil Air Patrol have missed six (6) consecutive unexcused absences and will therefore be removed from our attendance roster.
